Section 4: FIRST AID MEASURES

Section 6: ACCIDENTAL RELEASE MEASURES

Personal Precautions: Avoid contact with eyes. Do not rub eyes with hands during cleanup. No special precautions for dermal contact are needed. Wash hands thoroughly after cleaning up spill or leak.

Procedure to follow in case of spill or leak: Evacuate area. Identify source of leak or spill and contain with sand, earth, or containment bin. Cover remaining spill with inert absorbent material to soak up spill. Dispose absorbent material as non-hazardous waste. Rinse area with plenty of water and mop to sanitary sewer.
