3. Administrative Update - President Brad Mortensen

The president gave an update of the Hemingway and other awards. A new position is being created in the president's office to help with university strategic plans. The Bursars office is working with students affected by the federal government shutdown. Ongoing deliberations are still taking place regarding a new scholarship structure. Some changes were implemented last year. The goal is to find a scholarship structure that helps the greatest number of students.

4. Academic Affairs Goals and Program Responsibilities - Provost Madonne Miner

An update of the Academic Planning task force which has been meeting for two years was given. There is a desire to approach planning from the grass roots of programs and then the Office of the Provost will give commentary on those ideas. Three core objectives have been recommended by WSU stakeholders; they are value/quality, affordability and growth. This coming May the Provost's office will be gathering data from each department on how they can contribute in ways that are right for them. What are their initiatives, what resources do they need? Programs will be allowed to set their own SMART goals. Metrics should align with the college goals and direction.
