NEW & SUBSTANTIVE PROPOSALS: For inclusion of course and program proposals in the 2024-25 University Catalog, they will need to be passed by the Curriculum Committee at the <u>January 21/28, 2025*</u> meetings and then passed by the Faculty Senate at the **February 13, 2025*** meeting.

NONSUBSTANTIVE PROPOSALS: Non-substantive proposals must be approved by the UCC Chair by <u>January 31st</u> to be included in the upcoming year's catalog.

New courses at all degree levels that are requesting **course fees** must submit a Curriculog New Course Fee proposal. Courses not so identified will be ineligible to propose course fees for 3 years.

NEW New Graduate Program Proposals: Proposals for <u>new</u> graduate programs and their associated new courses have an extended deadline of <u>January 20, 2025</u>, to reach UCC for inclusion on the UCC January 28, 2025 agenda. All other graduate proposals that are not associated with a new program "package" are subject to the deadlines above.

New program proposals must be approved by the President's Council and Board of Trustees before they can be included in the University Catalog. Allow *at least* six *weeks* from the time the proposal is approved by the Faculty Senate for it to go through the President's Council and Board of Trustees. Additional approval is required from NWCCU before students may be recruited to a new program or financial aid can be given to students enrolled in the program, which can take another 2-3 months after approval by the Board of Trustees.
